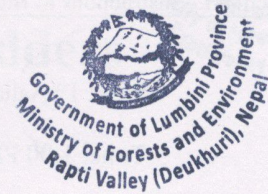

1. <sup>2</sup>*Government of Nepal (GoN)* has received a loan/credit/grant from *World Bank* towards the cost of *Forest For Prosperity* and intends to apply part of the funds to cover eligible payments under the Contract for *Procurement of Necessary Goods for Forest management (IFB NO: NP-MOTIFE-BUTWAL-169602-GO-RFB)*. Bidding is open to all eligible Bidders from all countries as defined in World Bank's Procurement Regulations for IPF Borrowers dated July 2016 (Revised November 2017 & August 2018).
2. The **Ministry of Forest and Environment, Forest For Prosperity project** invites *electronic bids* from eligible bidders for the *Procurement of Necessary Goods for Forest management* under National competitive bidding – Single Stage Single Envelope procedures.

Sealed bids must be submitted to the office *Ministry of Forest and Environment, Lumbini Province, Procurement Unit, Rapti Valley, Deukhuri, Dang* by hand/courier on or before **12.00 noon** on **31<sup>st</sup> day of first publication of notice**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM, on 31<sup>st</sup> day of first publication of notice** at the office of *Ministry of Forest and Environment, Lumbini Province, Procurement Unit, Deukhuri, Dang*. Bids must be valid for a period of **90** from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **110000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **90+30 days**)
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
